



PRIVACY POLICY

We limit access to Customer Information to those employees who need to know that information in order to provide services to you or to maintain or upgrade those products or services.

This privacy policy only applies to aboutMYmortgage.com LLC. This policy does not apply to the practices of companies that aboutMYmortgage.com does not own or control, or to people that aboutMYmortgage.com does not employ or manage.

Collection and Use of your Personal Information

aboutMYmortgage.com does not sell, rent or lease its customer lists to third parties.

aboutMYmortgage.com collects and uses your personal information to operate the aboutMYmortgage.com Web Site and deliver the services you have requested. Submission of Information
